The following must be submitted with this application:

1. A letter from the high school attended certifying the applicant is a student in good standing or was in good standing upon departure.
2. At least three (3) letters of recommendation or references from employers, teachers, counselors and/or community residents who have known you for at least two (2) years.
3. A student profile form to be completed by a teacher, advisor or official at present or most recent institution.
4. A transcript of grades from the high school attended through the most recent grading period.
5. A copy of your completed Financial Aid Form (FAF) for the initial school year to be covered by the financial aid to be provided by this program.
6. An Essay limited to one page or 500 words on **“Why I am a qualified candidate for this scholarship.”**
7. Conduct a personal interview with the Association.
